

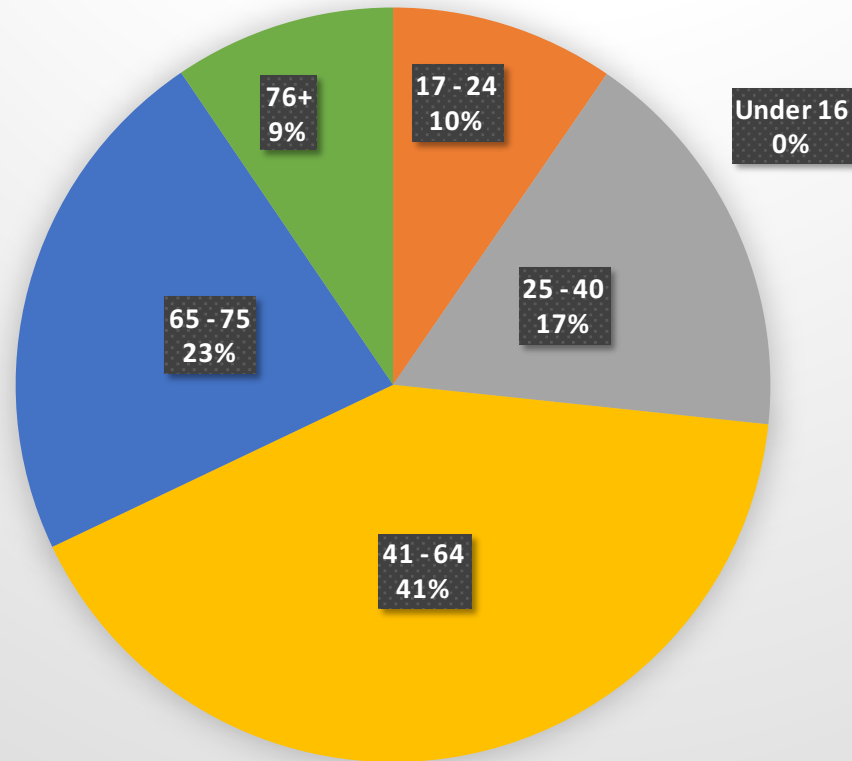

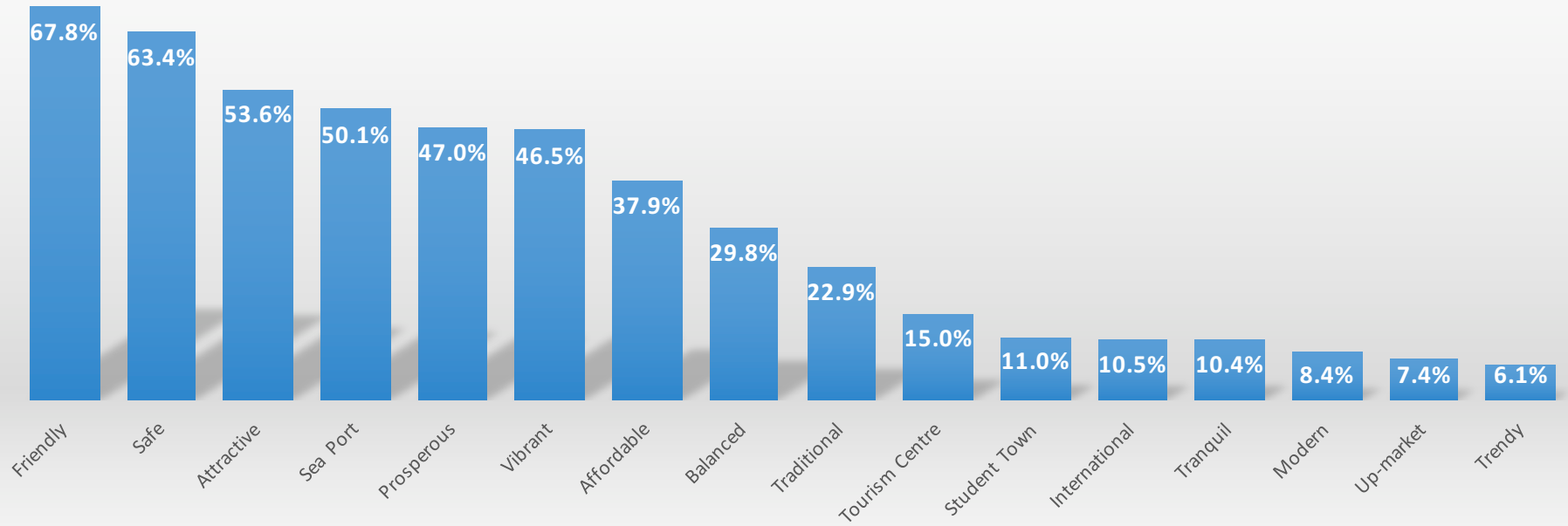
Feedback

- Survey open during March, April and May 2015
- 1,308 returns
- 83% completion rate overall
- **Statistical Significance**
 - Adult population (16 and above) of 18,592, confidence interval of 4 points
 - Confidence level of 95% = 582 returns required
 - Confidence level to 99% = 985 returns required
 - All questions achieve at least 95% confidence level, most 99%.
- Age group balance reasonable but distorted in favour of 65+

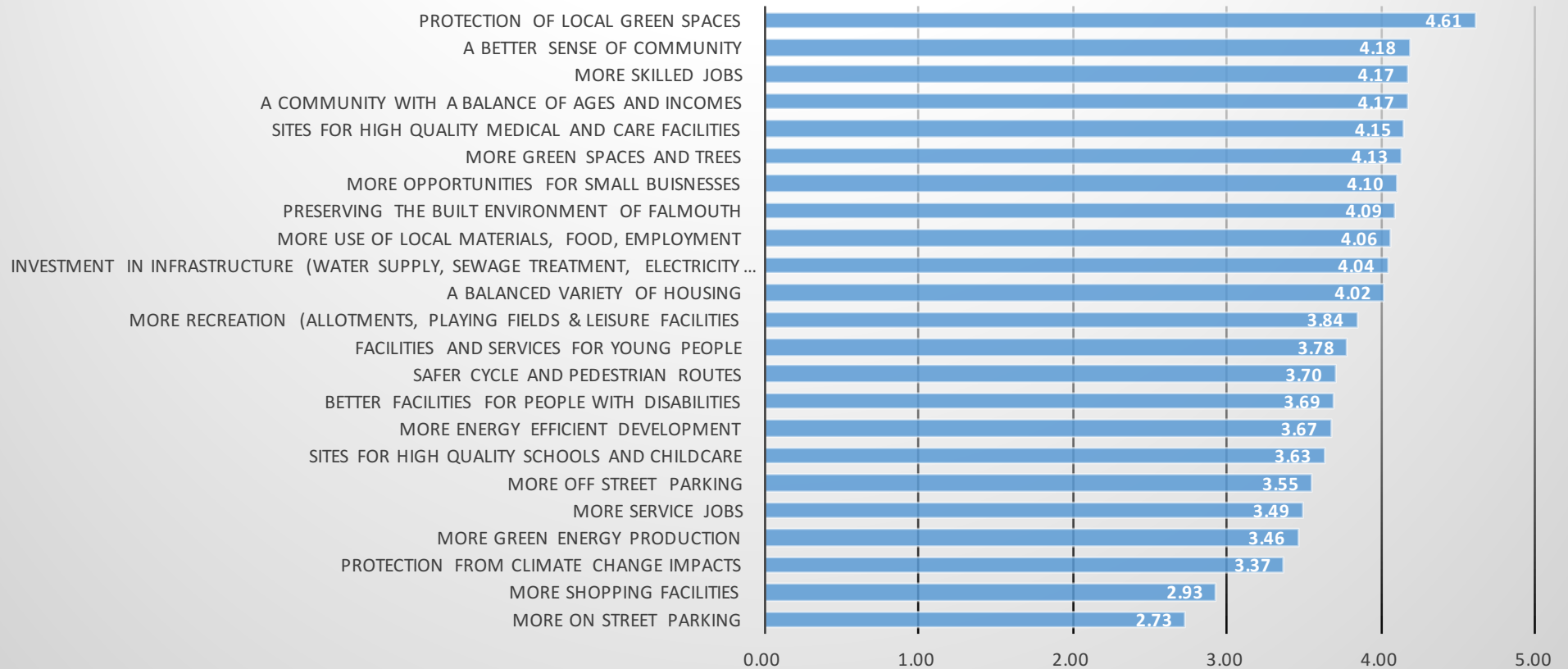

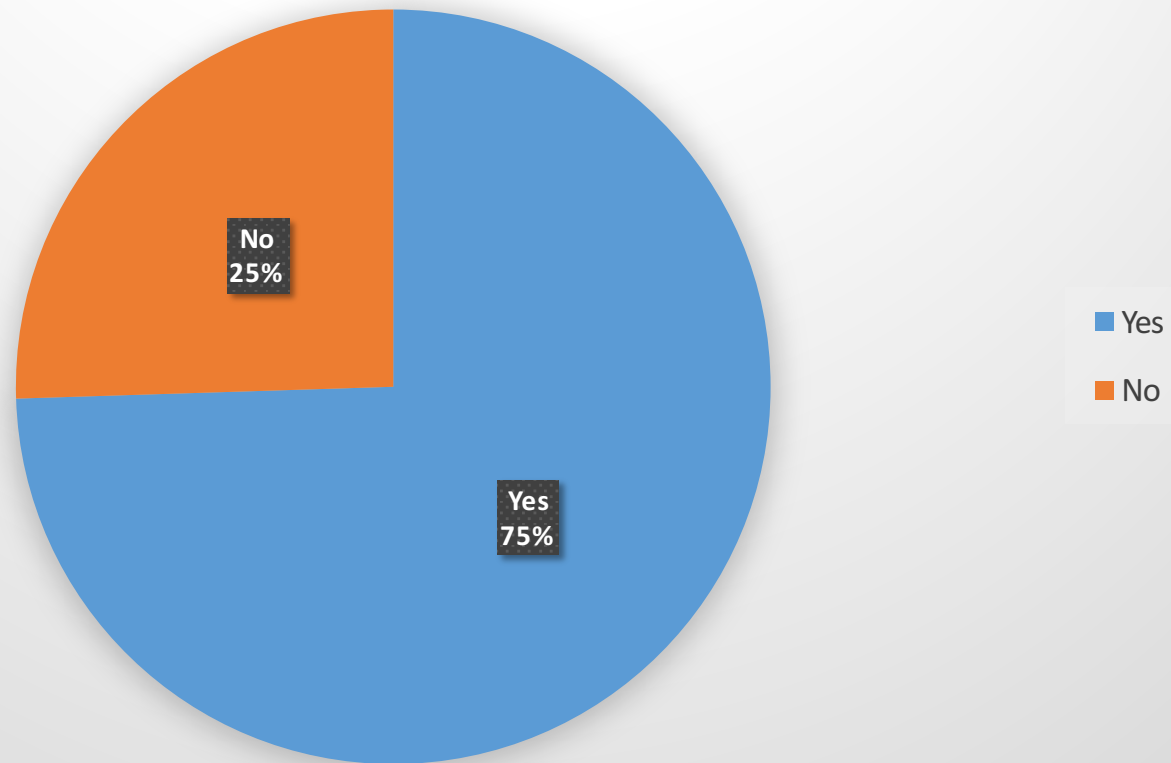
Q1. How would you like Falmouth to be described in 15 years' time?



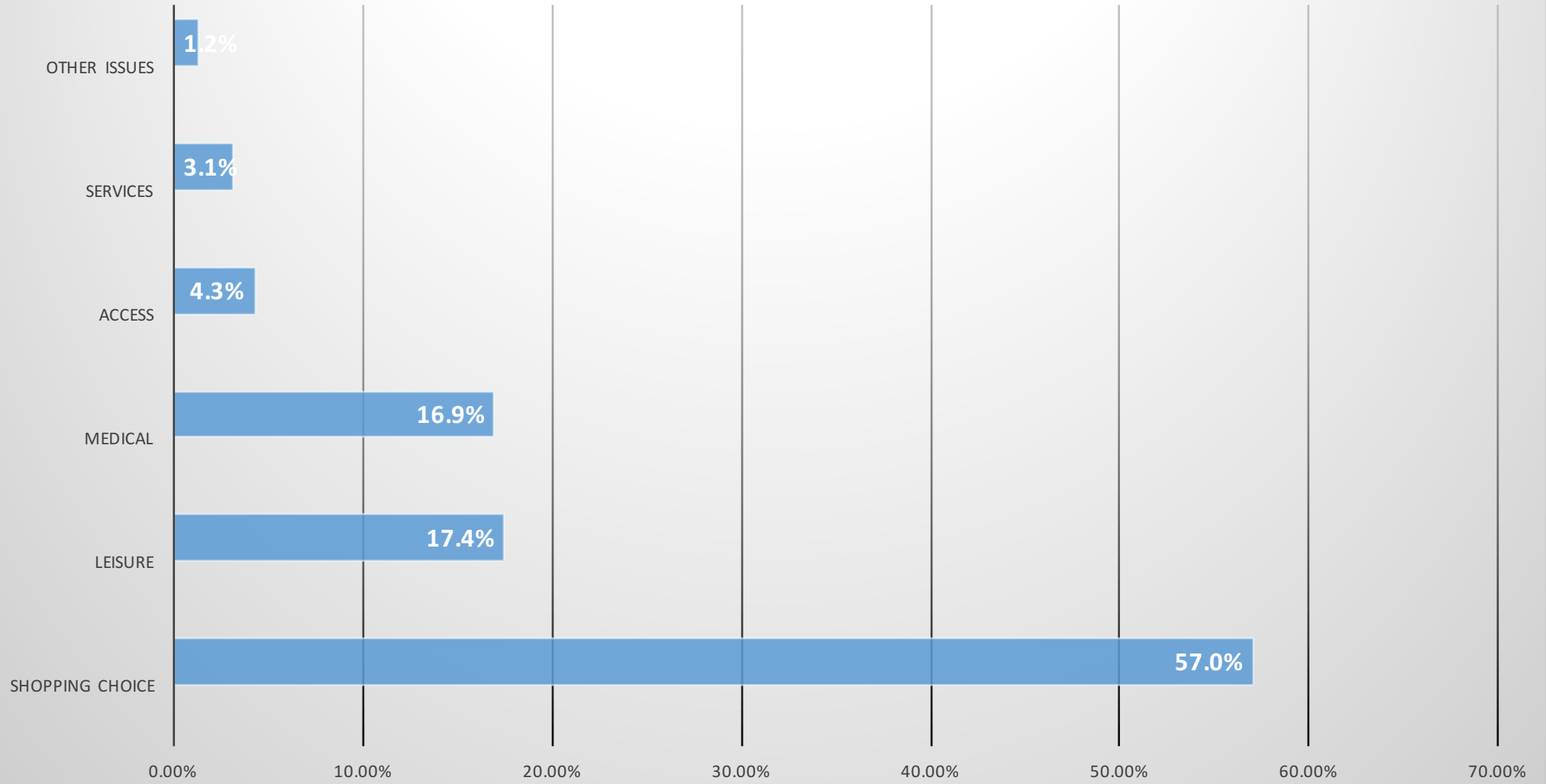
Q2. With sustainable development in mind, what do you think are the most important benefits the Neighbourhood Plan should bring to Falmouth?



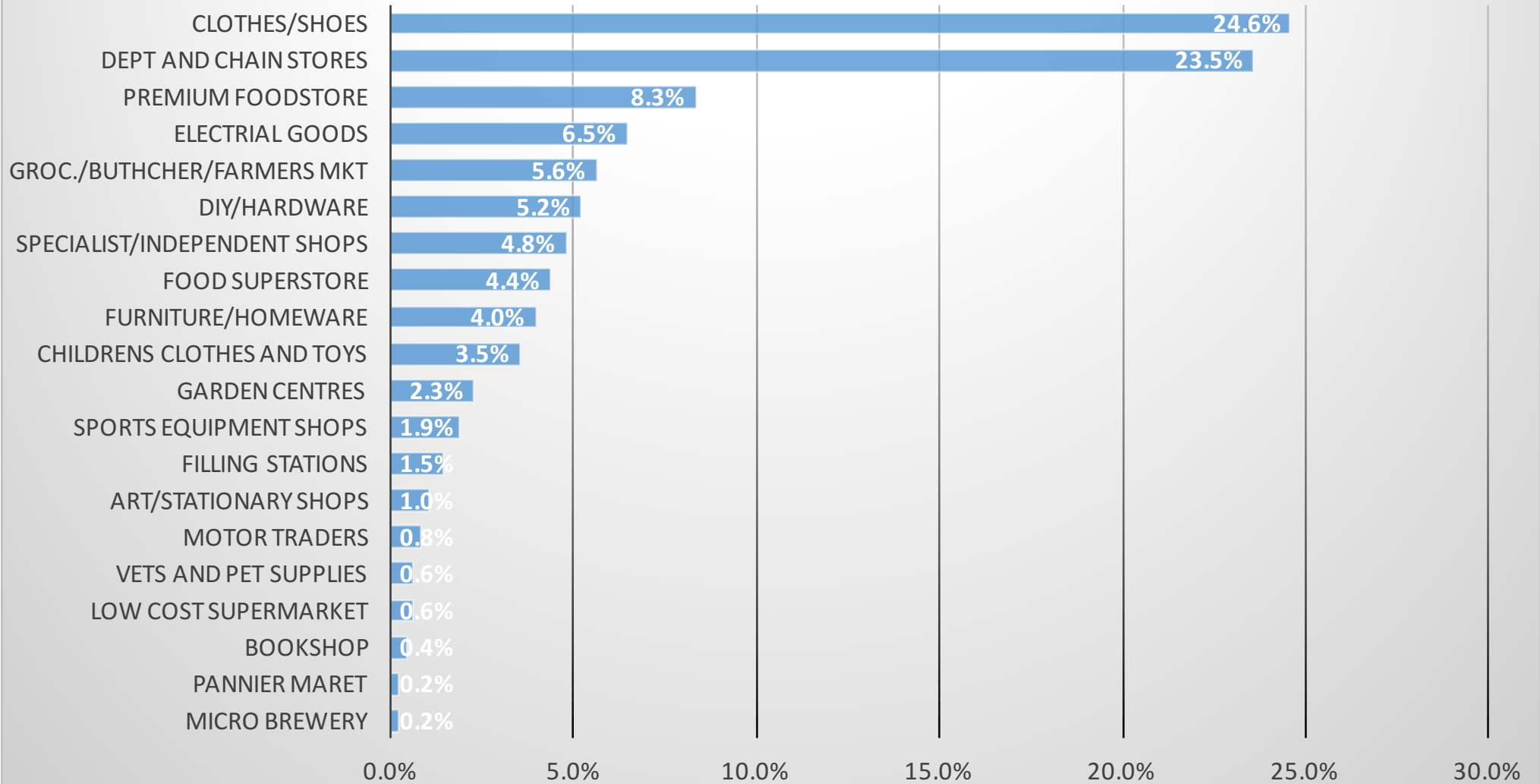

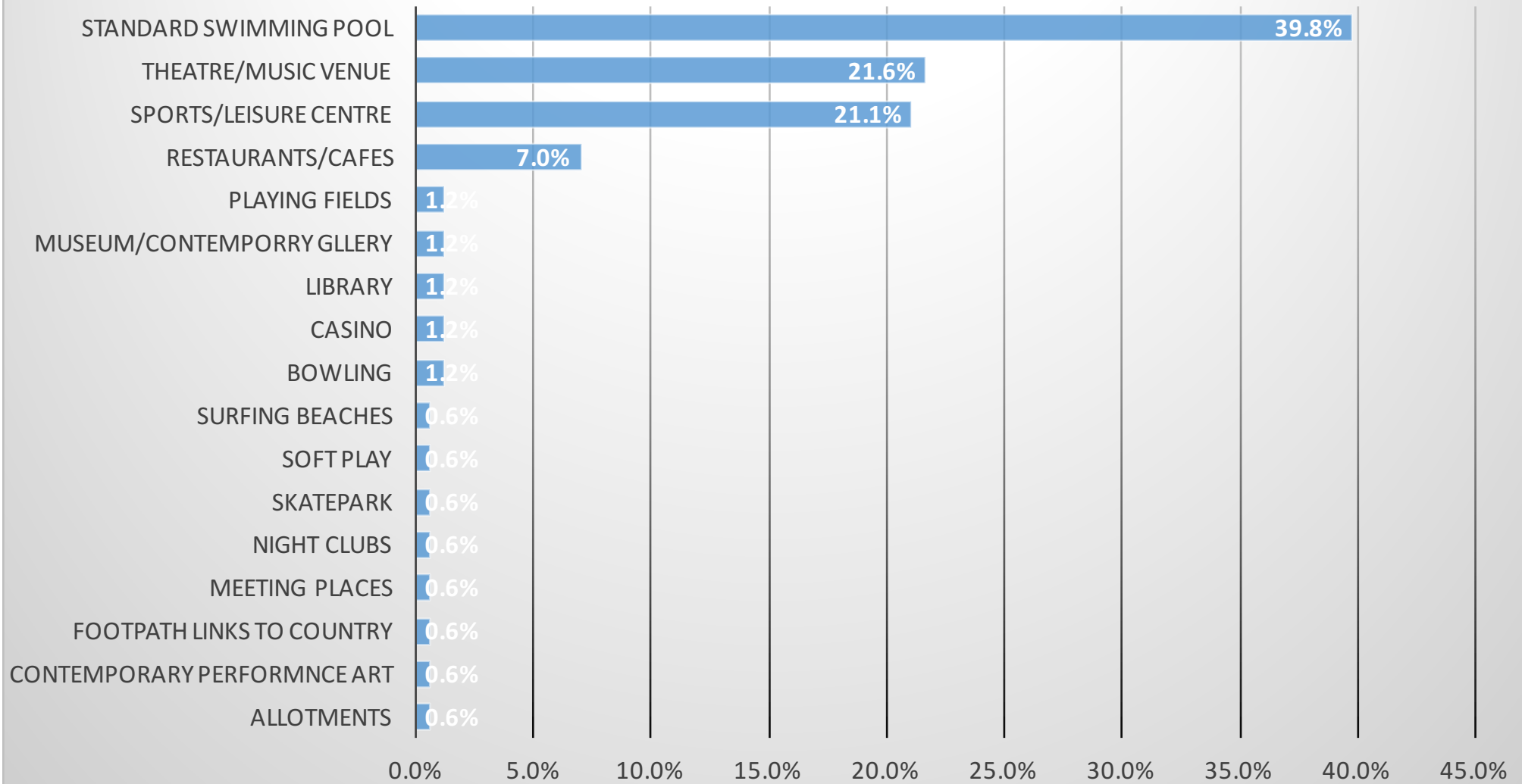

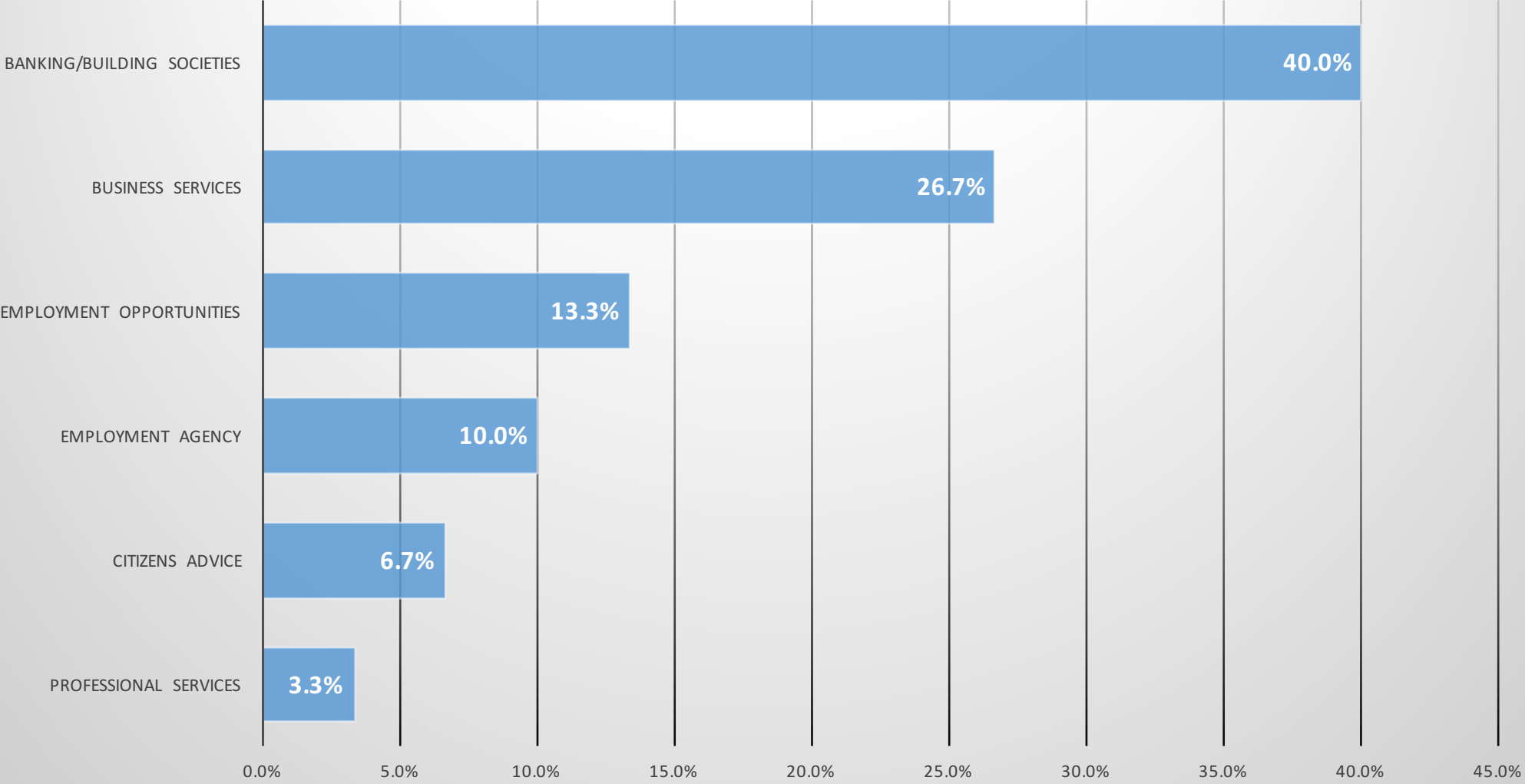

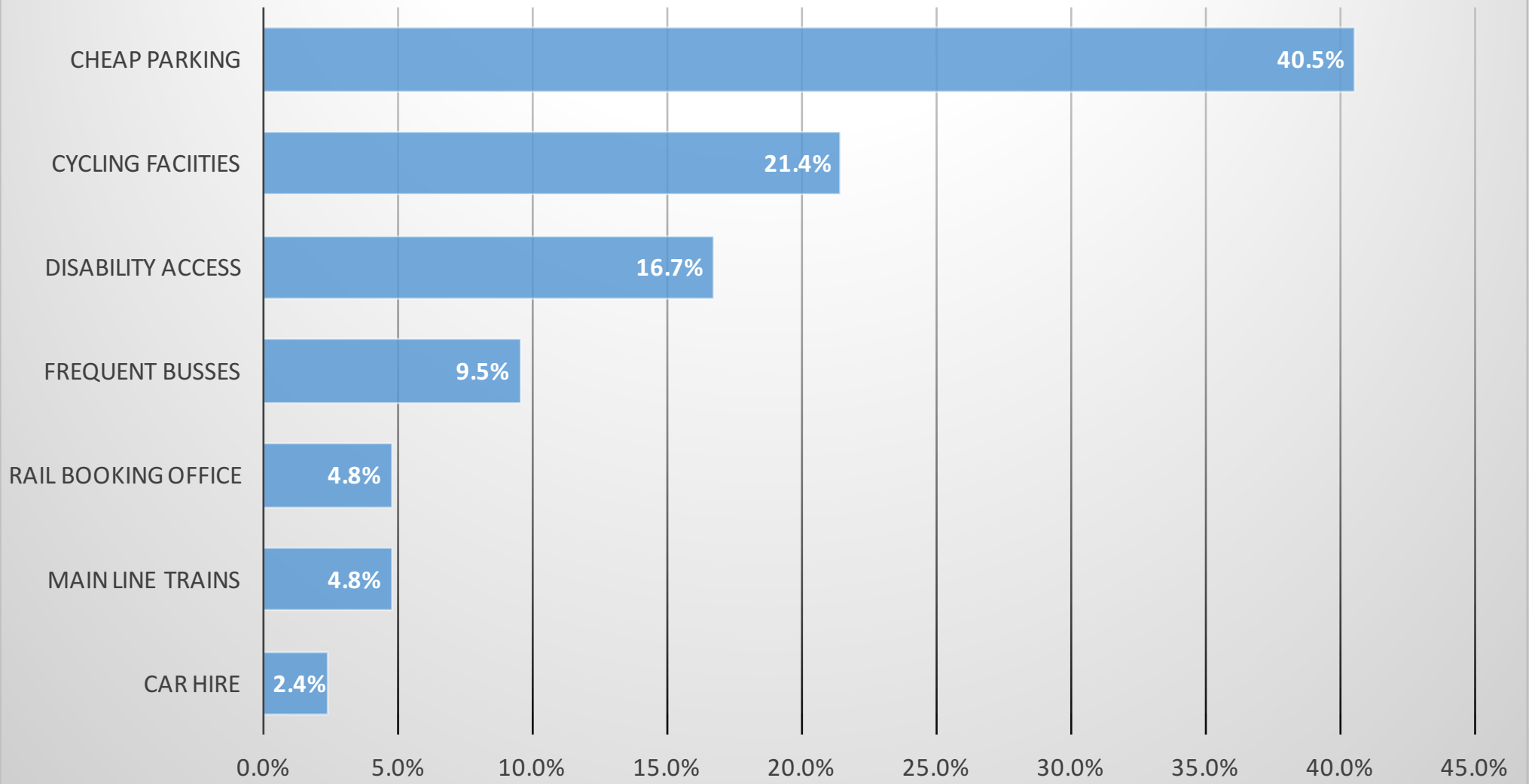

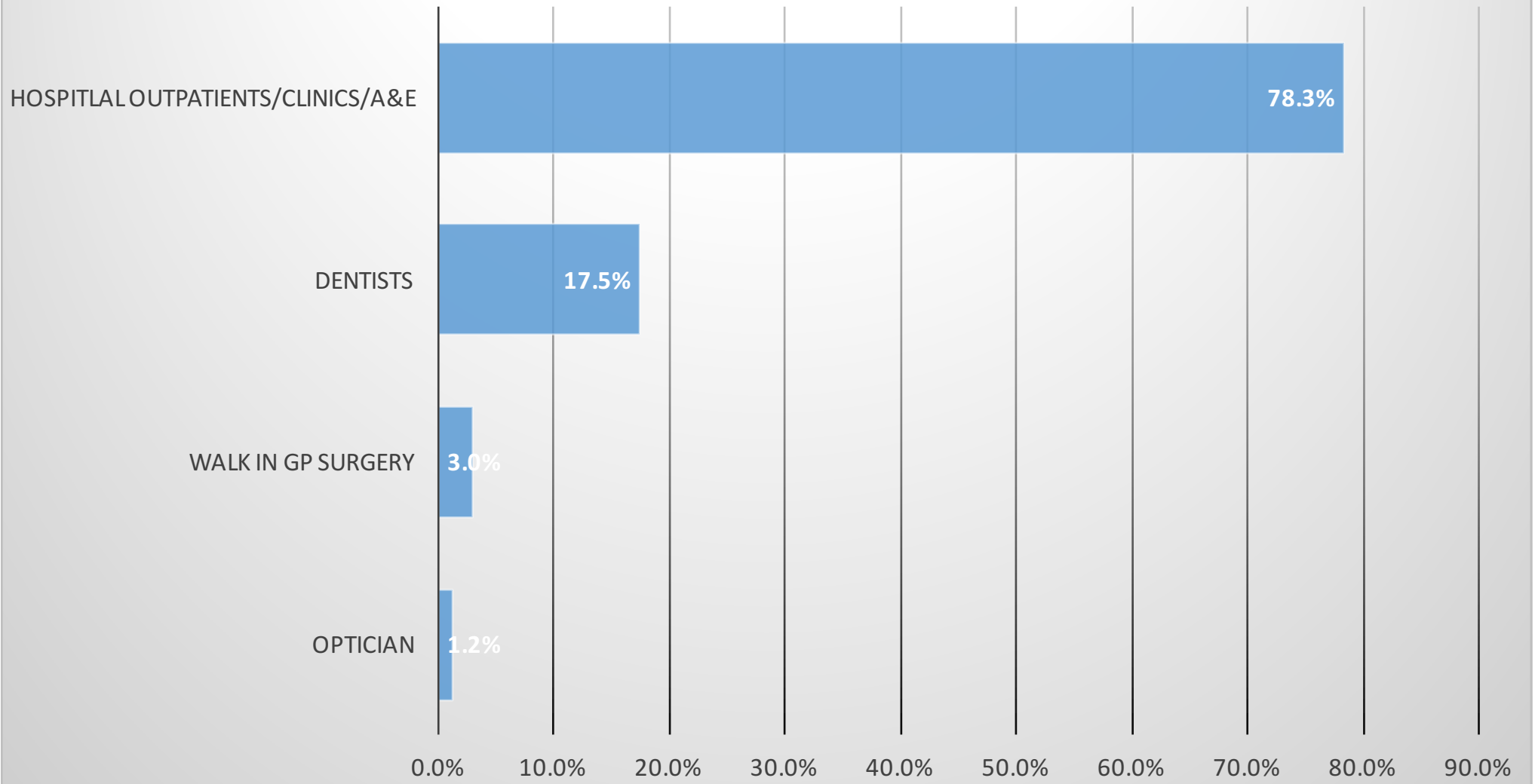

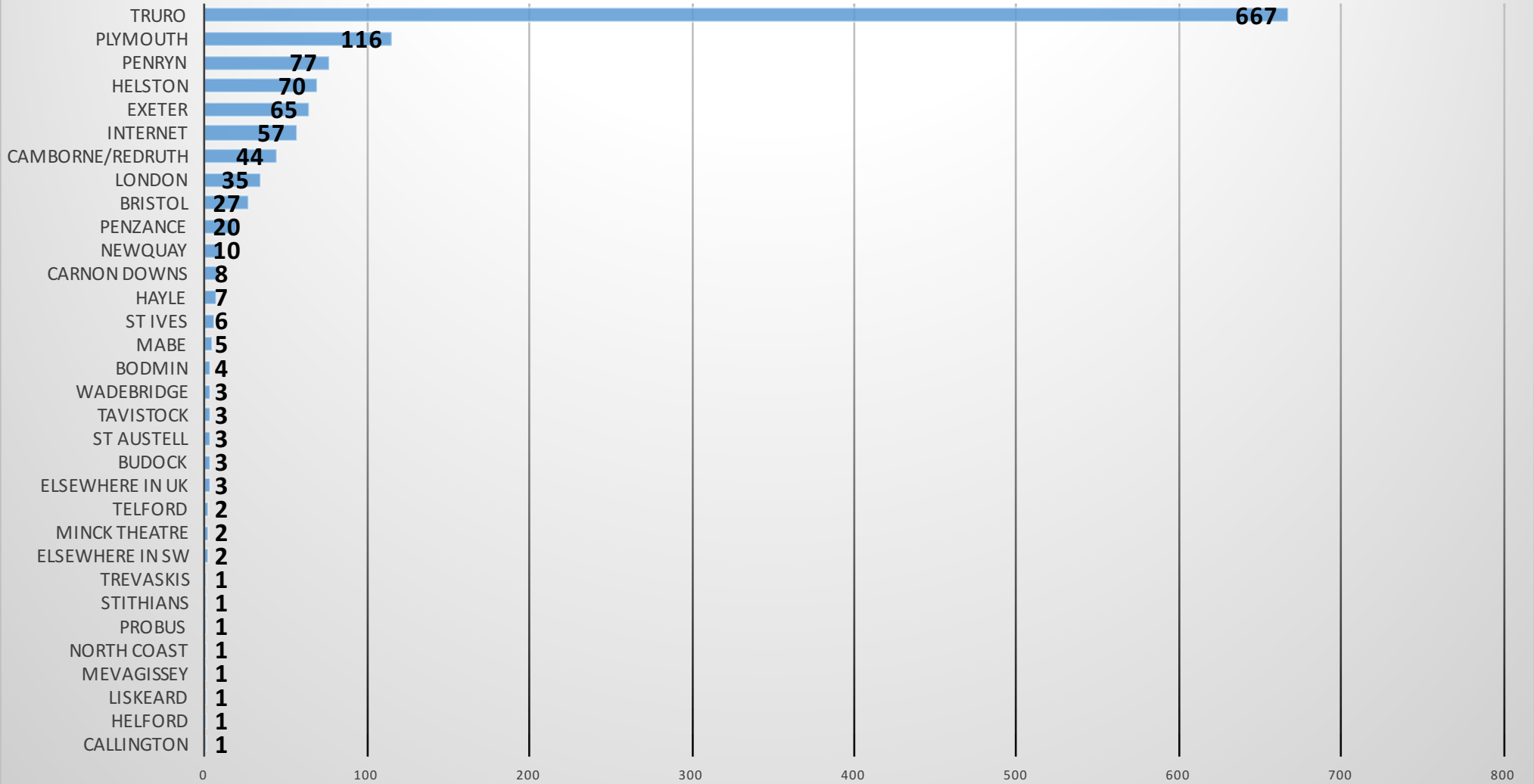

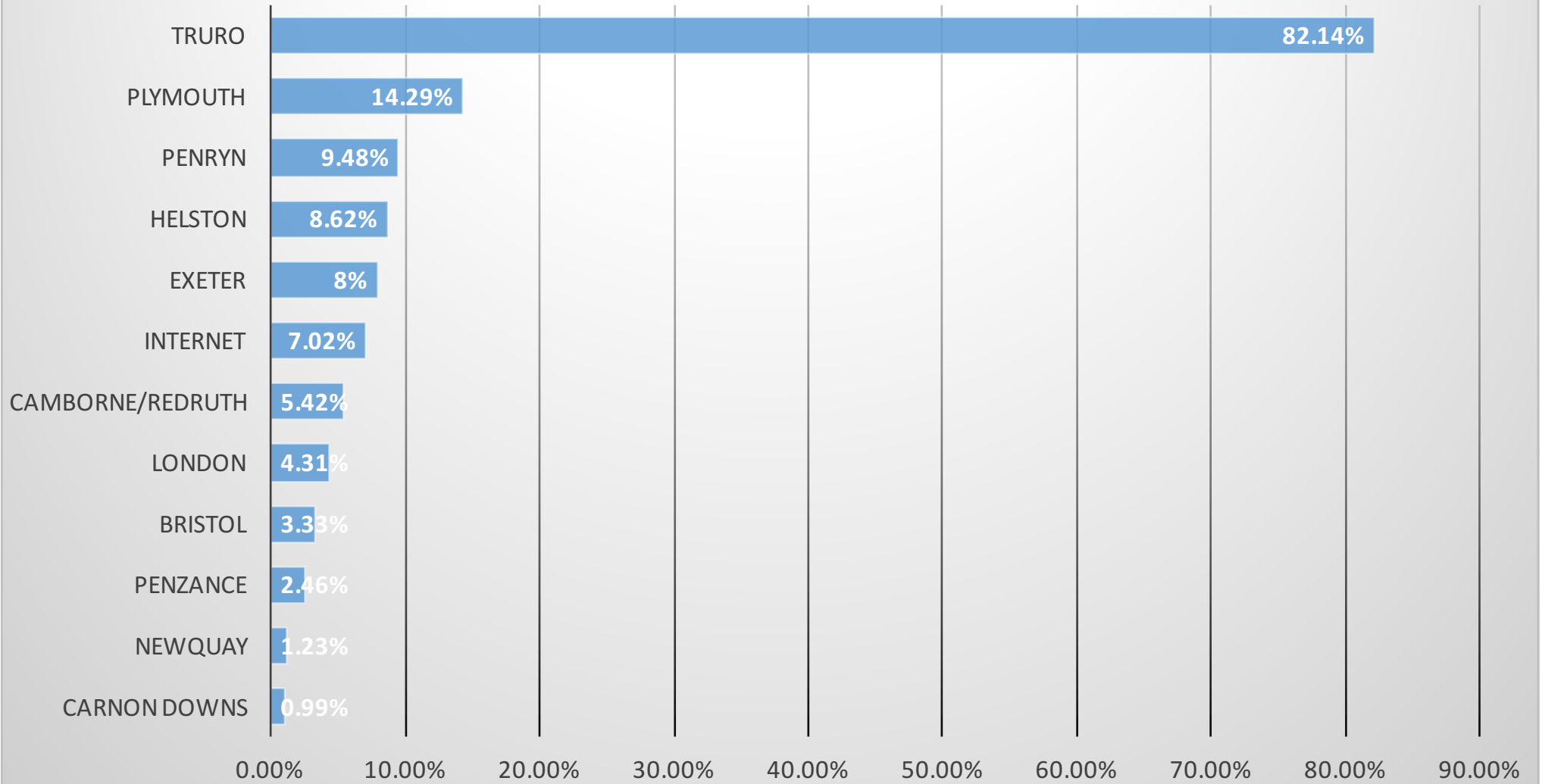

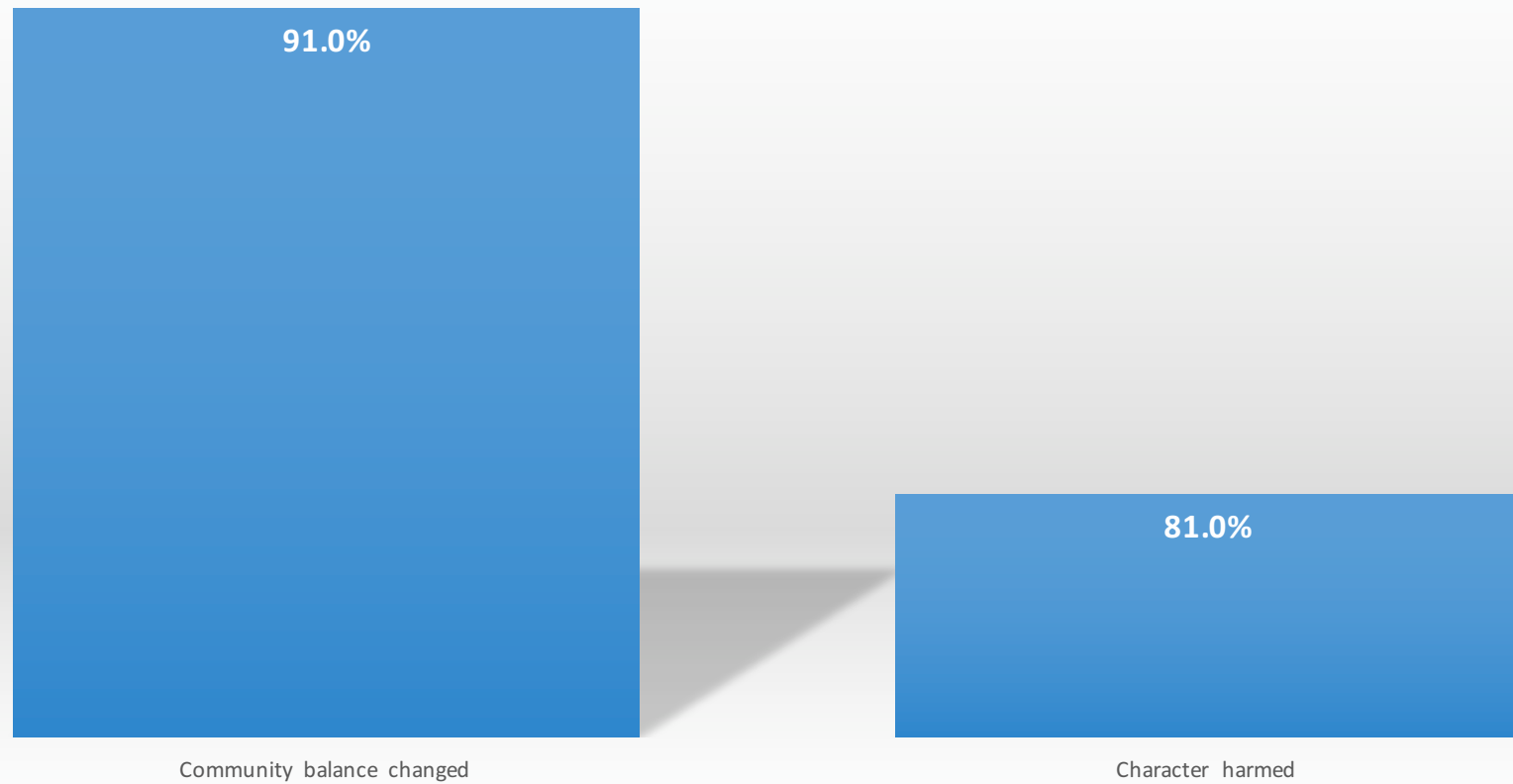
Q8. Thinking about where you live what do you consider are the most important design features that should be considered in new development?



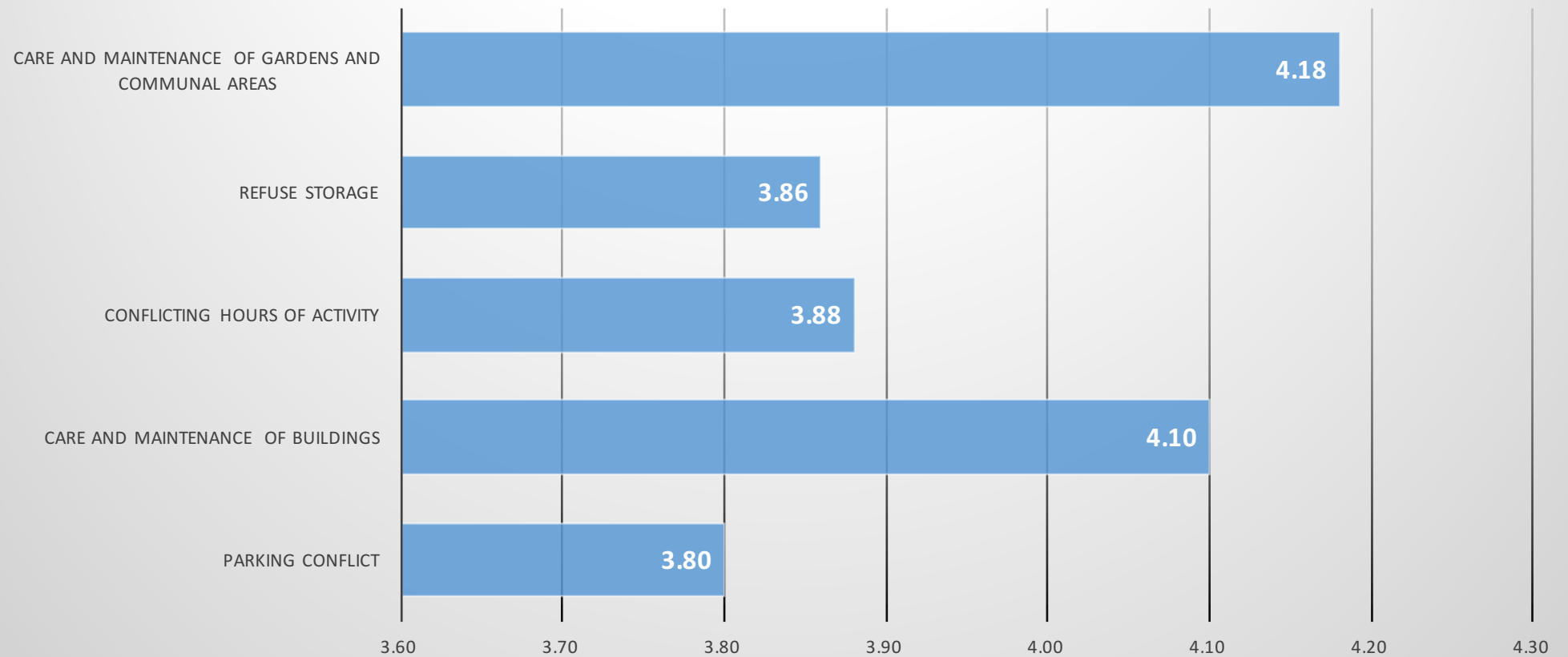
Q9. Areas of Falmouth where the balance of the community or character of the area are at risk of being harmed by changes in accommodation and occupancy type



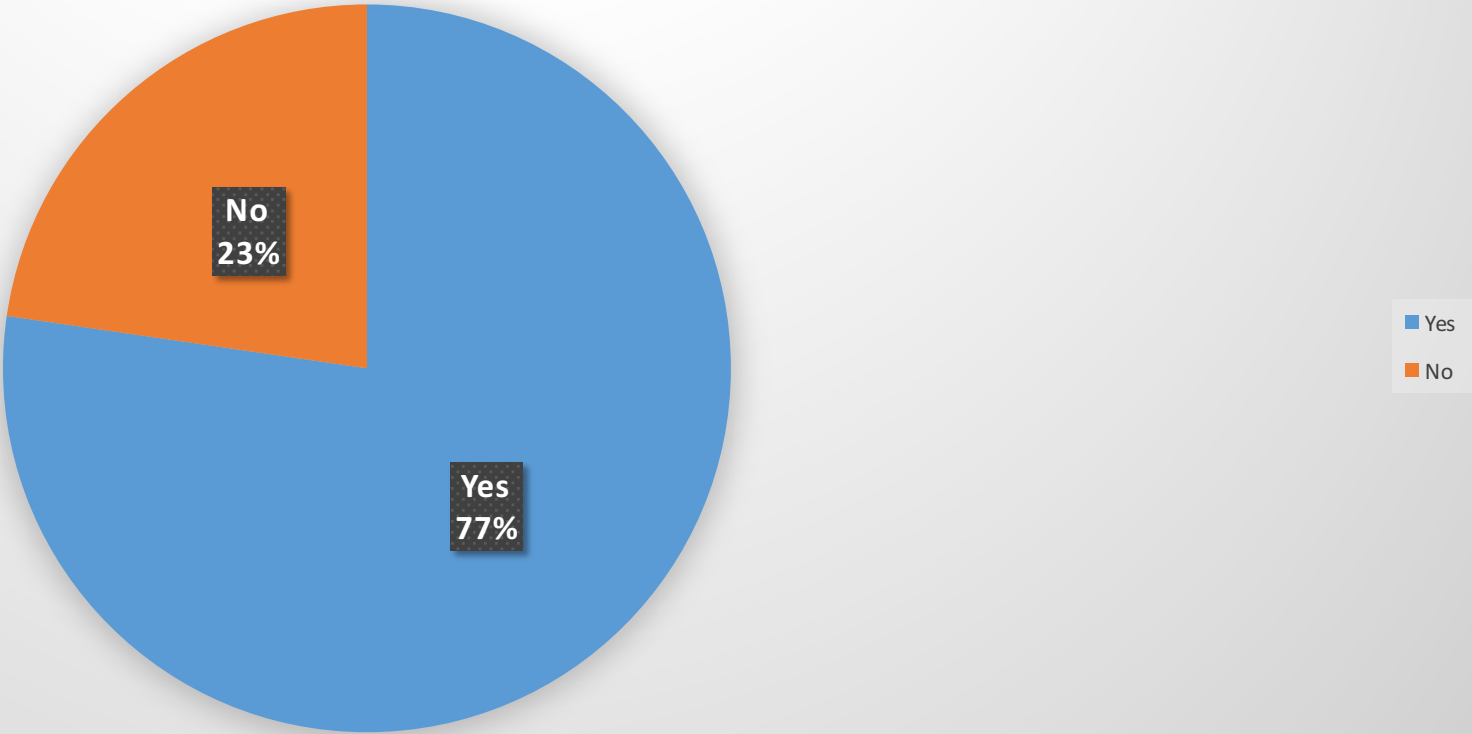

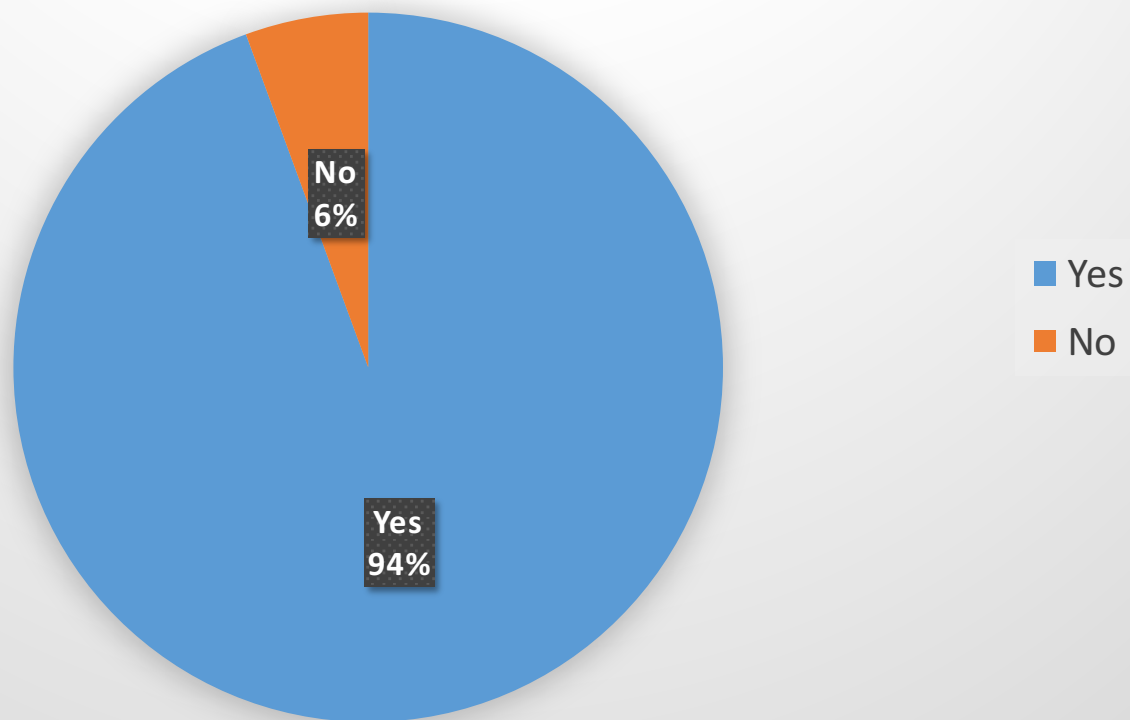

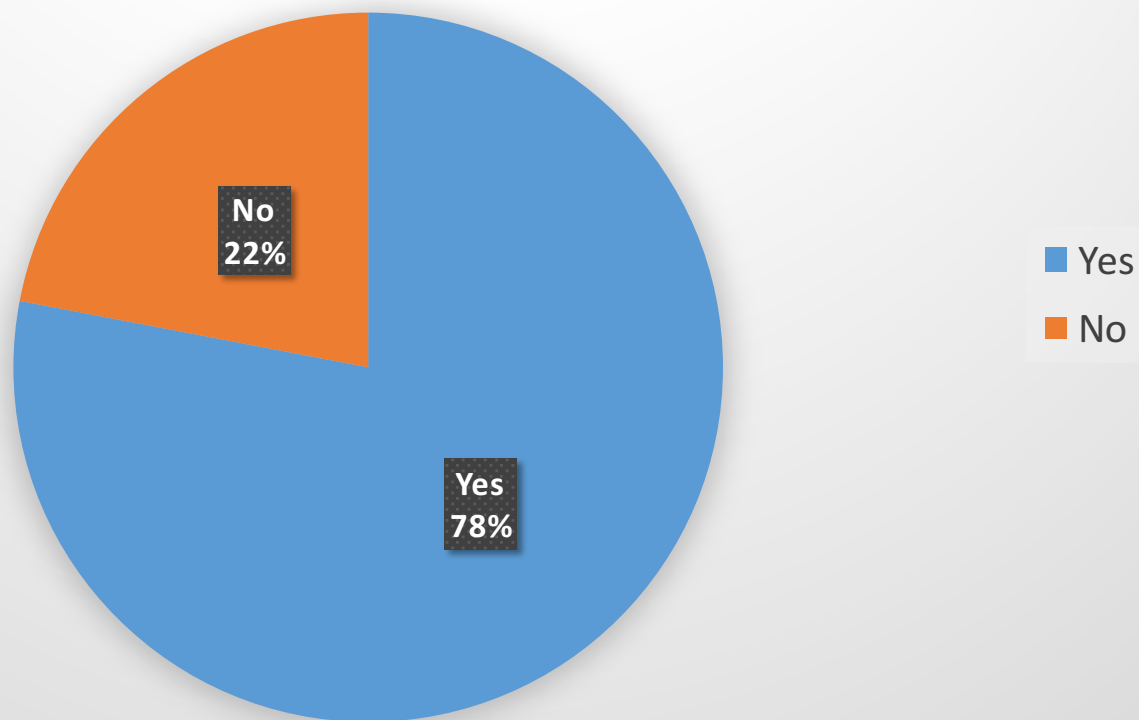
Q12. Would you support the principle of an Article 4 Direction that would control the spread of houses of multiple occupation in Falmouth?



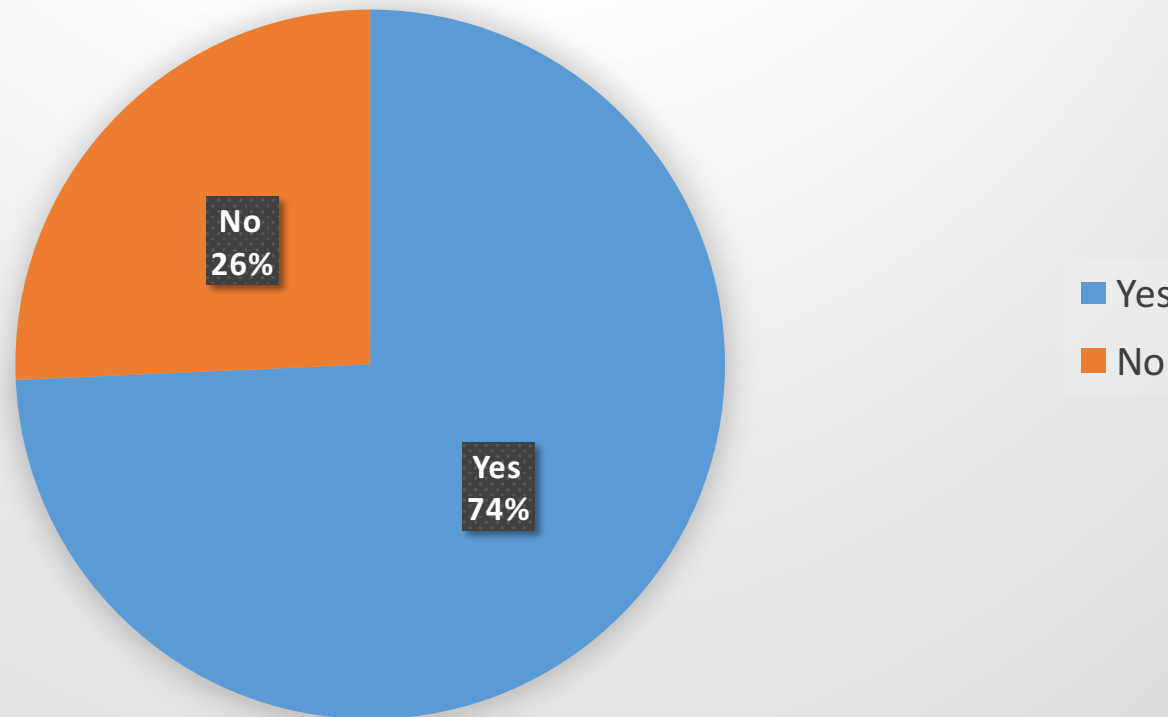
Q13. Do you think that further developing Falmouth's docks as a centre for marine engineering would provide more jobs in Falmouth?



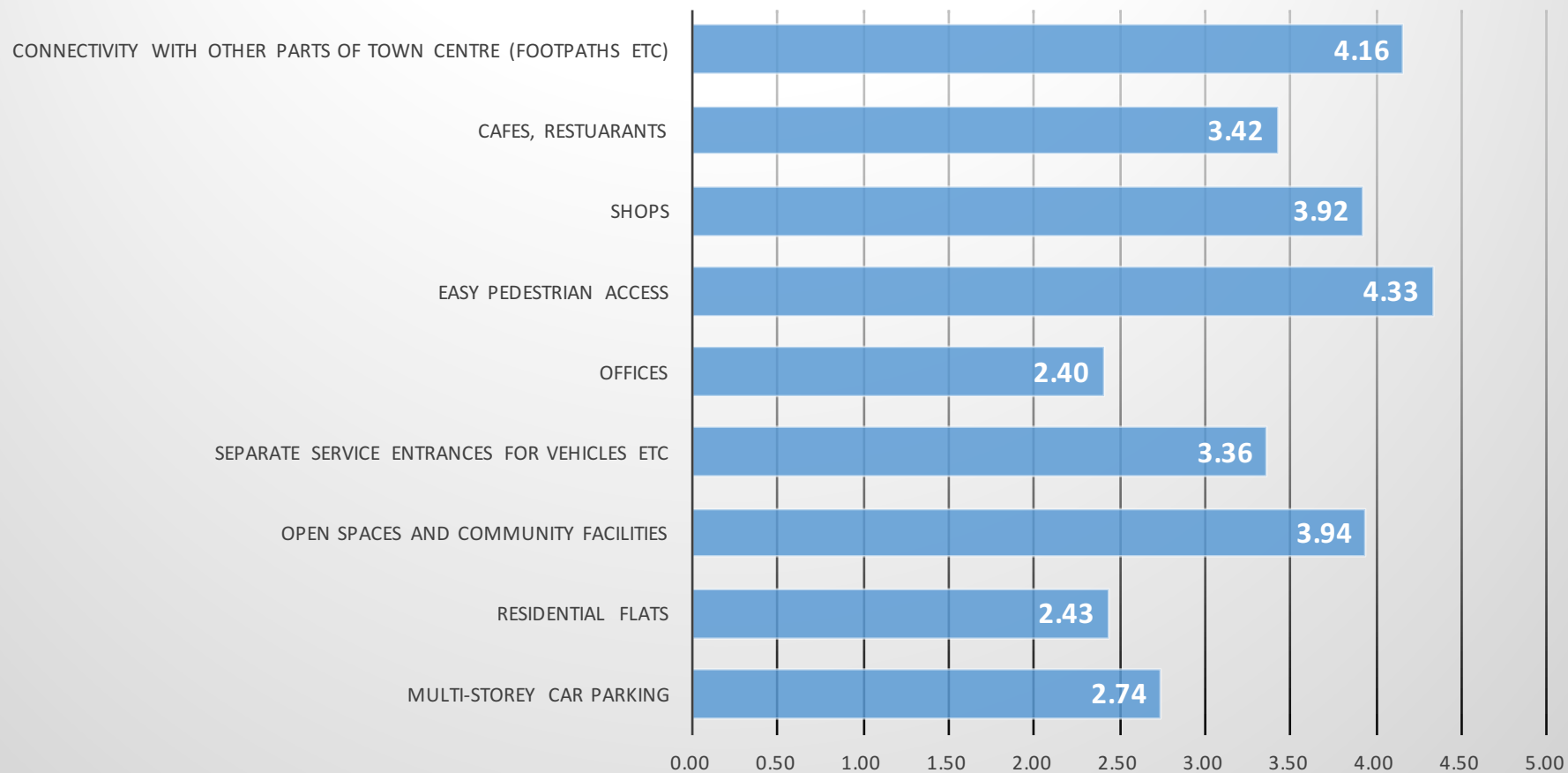
Q14. Do you think that dredging Falmouth Harbour to provide a deep water access channel to the docks area is a good idea?



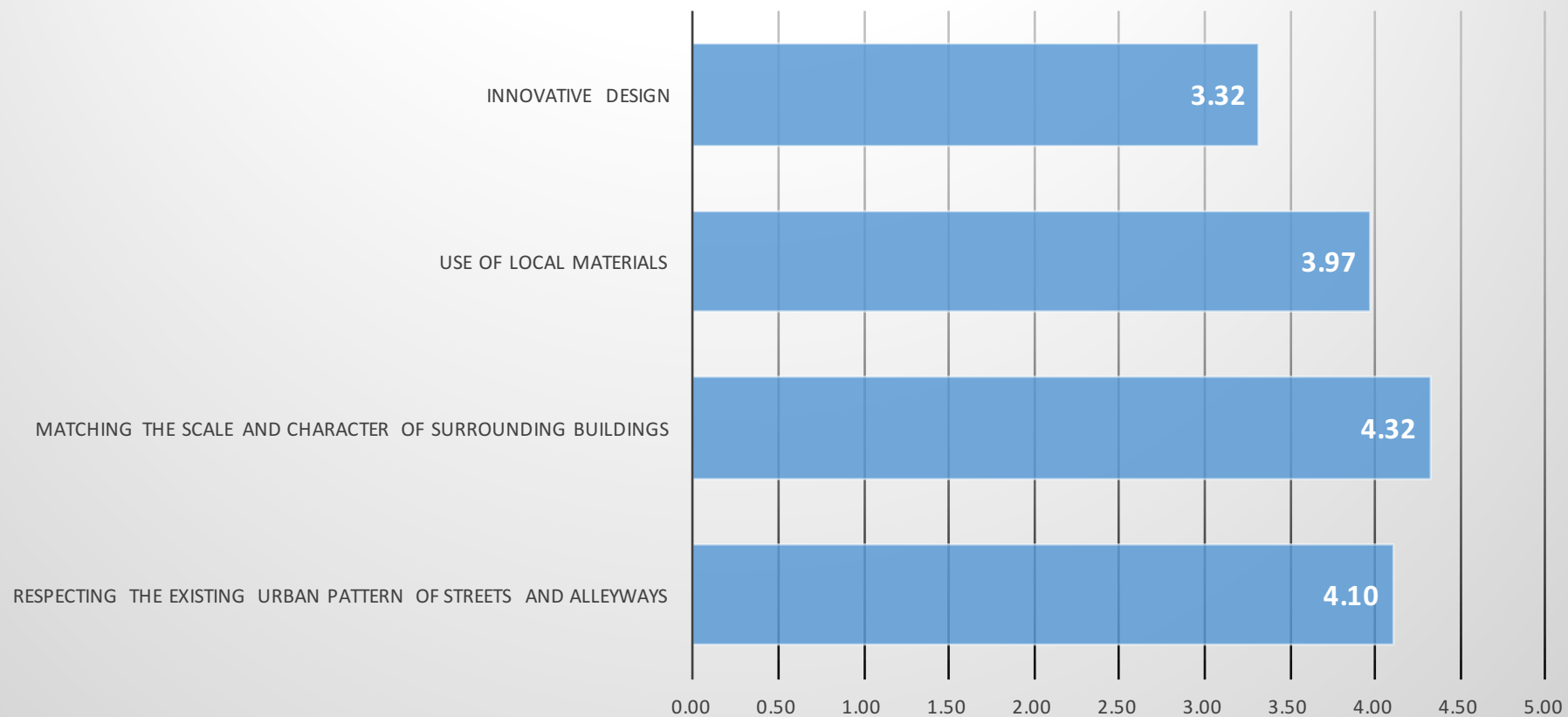

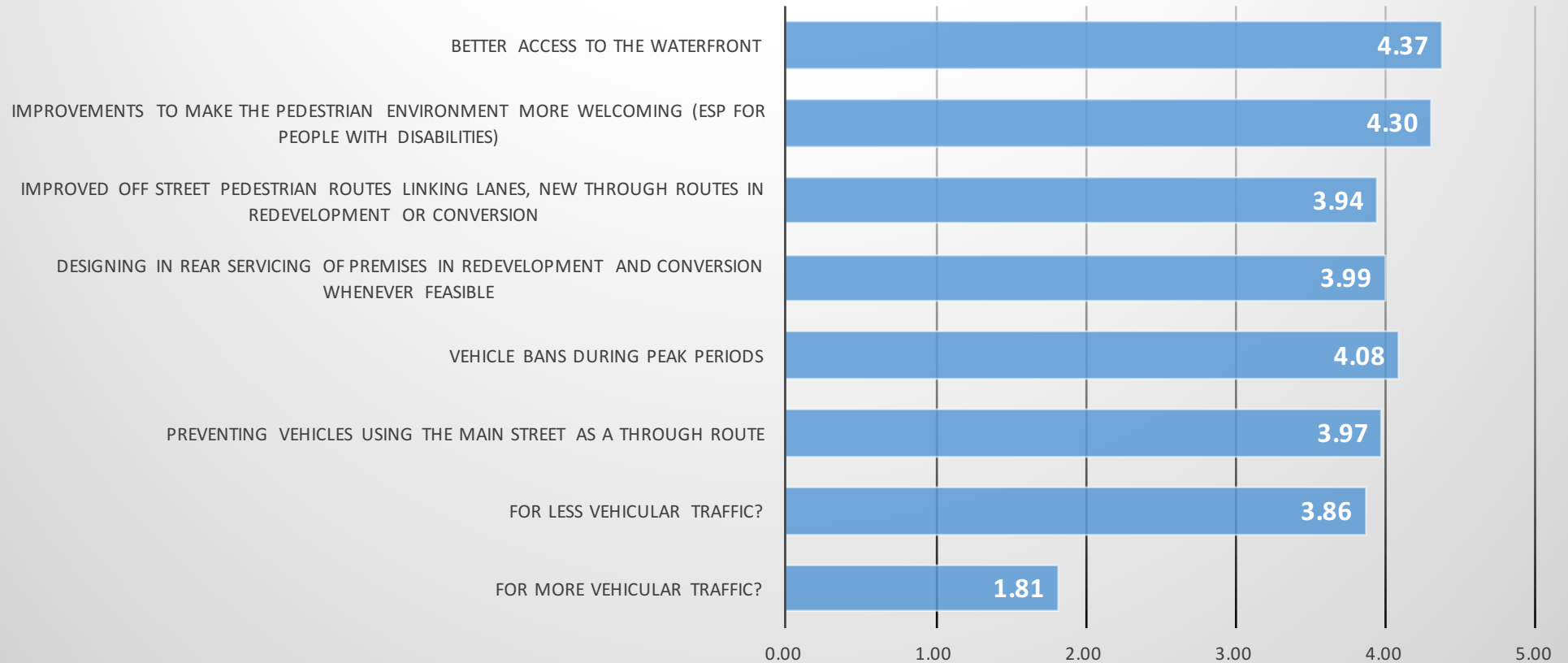
